## TERM AND CONDITIONS FEE POLICY

- Fees are subject to a minimum annual increment equivalent inflation costs
- Fees are payable in advance before 1st day of the term
- All other invoices are payable on presentation

- Any bank fees related to payments will be charged to the parents account
- A full terms notice in writing or the equivalent fees in lieu therefore is required prior to the withdrawal of the student
